

NETE 60003: Interpreting the New Testament
3 Semester Hours

Instructor: Shelly Matthews, Professor of New Testament

Description of Content: This introductory course for Master's level students is designed to lay a foundation for lifelong *critical and constructive interpretation of the New Testament*. The course will provide a historical introduction to the writings of early Jesus followers contained within the New Testament, along with related sources from the first and second centuries of the common era. It will introduce students to tools for interpreting the New Testament both in its historical context, and with an eye to present day communities and their theological and ethical concerns. The course provides practice in close reading of biblical texts, as well as opportunities for debate and dialogue concerning its meaning.

Class Procedures: Lecture, small group work, and discussion

Requirements:

1. Attendance and informed participation in the class sessions
2. One book review
3. Occasional in-class writing and/or written responses to the reading
4. Mid Term Exam and Final Exam
5. Two short exegesis papers (4-6 pages each)
